- 1. The minutes of the previous meeting was read and passed
- 2. The consolidated report of attainment analysis of Course Outcomes of all the programmes was reviewed. It was insisted that to improve the Course Outcome attainment the faculty members may be motivated to use innovative teaching methods like collaborative learning, flipped class room, lecture with lab support and project based learning.
- The IQAC suggested that the Course Committee and the Program Assessment Committee should rigorously analyze the attainment of course outcomes after every Periodical Test and take corrective measures.
- 4. The attainment analysis of POs was reviewed. The suggestions recommended by the various Department Advisory Boards were discussed in detail. It was suggested that the Departments implement those suggestions meticulously.
- IQAC suggested that students must be encouraged to take up projects that try to solve problems faced by the society. This would enhance the attainment of Programme Outcome that addresses the Graduate Attribute, Engineer and Society.
- 6. The attainment analysis of PEOs of all the programs was reviewed.
- The members of the IQAC suggested that to improve the core competency of the students a technical aptitude test may be conducted by the programmes at the end of every semester.
- It was insisted that to motivate students for higher studies and participation in other
 competitive examinations the period allotted in the regular time-table of VII semester
 students should be used effectively.
- The goals and objectives of the Perspective Plan document were discussed. It is decided that the Perspective Plan may be submitted for approval in the next Governing Council meeting
